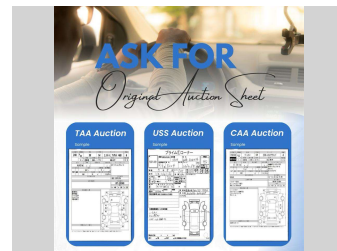

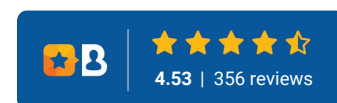

These fees can vary per lender and other non-mandatory fees and charges may also apply. The total amount of repayments has been calculated by multiplying 260 weekly repayments (based on a 60 month term) by the weekly repayment amount of \$59.33 which equals \$17,461.43.
